POLICY

MOTION WAS MADE by Mrs. L. DeMars to approve updating the Senior Trip Guidelines to agree with student handbook and read as follows:

Student Contribution. The 9th grade class may sponsor a maximum of 4 activities during the fiscal year. The 10th and 11th grade classes may sponsor a maximum of 5 activities during the fiscal year. The 12th grade may sponsor a maximum of 3 activities during the fiscal year.

NYS MINIMUM WAGE INCREASE

MOTION WAS MADE by Mrs. L. DeMars to approve increasing the substitute cleaner and substitute cafeteria helper rates to \$14.20 per hour and to increase the non-certified substitute teacher and LPN rates to \$103.00 per day effective December 31, 2022. These increases are due to the NYS minimum wage increase to \$14.20 per hour. Seconded by Mr. N. Poulin and unanimously carried.

RESOLUTION DATED December 7, 2022

NEWCOMB CENTRAL SCHOOL DISTRICT BOARD OF EDUCATION REGARDING ADVOCACY PRIORITIES FOR THE 2023 LEGISLATIVE SESSION

- WHEREAS, the Newcomb Central School District strives to provide an outstanding education and post-secondary pathway for each and every student; and
- WHEREAS; the district recognizes the deep commitment shown by the legislature and the Executive to fully fund the foundation formula; and
- WHEREAS, the District works diligently to meet the needs of all students while still fulfilling its core mission, even while in our third year of a pandemic, and
- WHEREAS, the District is facing significant increased costs due to inflationary factors for labor, fuel and goods; and
- WHEREAS, property tax levy legislation at the state level has provided an increased need for State Aid to maintain quality programs; and
- WHEREAS, public schools are being asked to do more for students than ever before, so they are prepared for college, military or a career; and
- WHEREAS, each child in Newcomb Central School District only has one opportunity to go through the full elementary and secondary educational experience;
- THEREFORE, BE IT RESOLVED that the Newcomb Central Board of Education calls on the New York State Legislature and Governor Kathy Hochul to act upon the following priorities:

Fund and Adjust the Foundation Formula

Include a due minimum increase for all districts, regardless of Foundation Aid phase-in level.

Maintain the "SAVE Harmless" provision.

Fully fund expense based aids.

Support for an initial evaluation of the current cost to educate a successful student.

Increase the \$30,000 threshold on BOCES Aid for Career and Technical Education (CTE) teachers.

Support universal free meals for students by maintaining the availability of universal meals at no cost to families.

Workforce Development

Increase flexibility in teacher certification requirements to allow districts to more effectively utilize those teachers that they are able to hire.

Make adjustments to Tier 6 of the retirement system to help districts retain staff by making longevity more valuable.
